### Investigating the Significance of SME Loans on the CMSME Entrepreneurs' Socio-Economic Development in Bangladesh

#### **Abstract**

Bangladesh is a developing country where industry and service are the biggest sources of GDP. The country's 25% of GDP is generated from SME sector. Thus, the study's chief objective is to identify whether loans provided in SME can significantly impact the socio-economic development of the entrepreneurs. As there are five clusters including cottage, micro, small, medium and large enterprises, the study particularly encountered each of them with similar KII based questionnaire and statistically tested the responses. As of the binary responses being configured, the reliability and validity of the questionnaire was tested with Cronbach's Alpha. Linear Probability Model, Logistic Regression Model and Correlation Matrix were used to statistically test the hypotheses and intervariable correlation. The result found significant outcome with respect to finding relation between the entrepreneurs' having benefits from SME loans and their socio-economic development. The results were checked with heteroskedasticity and multicollinearity tests for what any relevant biasness could be restricted sharply. Finally, the research found that benefits from SME loans are maximum among the cottage, micro and small entrepreneurs comparing to medium and large entrepreneurs, though in all cases it's seen that, SME loans have significantly impacted the socio-economic developments in the samples considered.
