Islamic Capital Market Products and Their Governance

Abstract

Bangladesh despite progressing very well in Islamic banking in terms of securing a significant market share, it greatly lags in Islamic capital market. This is the case despite the population of Bangladesh are mostly Muslims and holds strong religious sentiments. With increased awareness about the Shariah prohibitions in financial dealings and due to consecutive scandals in the banking sector, now is the high time to develop the Islamic capital market (ICM) in Bangladesh. This is essential for the development of the Bangladesh economy. This research identifies the initiatives taken by other countries in developing their ICM and the products they have introduced in their ICM. The research then identifies the Shariah compliance requirements of ICM that Bangladesh needs to ensure to assure the Shariah sensitive investors and build market confidence. Subsequently, the research identifies the issues and challenges that are currently present in the ICM products in Bangladesh and provides a few recommendations for the consideration of the concerned authorities.
